General Conditions of Sale

- All quotations, tenders and price lists are subject to withdrawal without notice, and any acceptance of any quotation, tender or price list will not effect a binding contract, unless and until confirmed by us.
 - Notwithstanding any offer, quotation, tender or price list, orders are accepted only subject to the conditions that the goods will be invoiced at the prices ruling at the date of their despatch.
 - In the event of an Account not being paid punctually, we reserve the right to cancel any Contract, order or balance or portion of an order, and any claims which we may have at law shall not be prejudiced thereby.
 - For period tenders, orders are accepted only subject to the conditions that the goods are available for sale.
- Offers to deliver goods are for delivery to a good hard and reasonably accessible road nearest to the site where the goods are to be employed or stored.
2. On the due arrival of our delivery vehicle it is the responsibility of the customer to unload the goods promptly. The customer shall be responsible for any damage during unloading and for all costs occasioned by his undue delay in commencing or carrying out this work or by his failure to unload. When products are unloaded by our crane hoist, supplementary conditions of sale which govern unloading appliances override these general conditions only to the extent to which the two are inconsistent.
 - Orders are accepted, and promises for delivery given, conditionally on our being able to secure the necessary labour and material.
- Offers to supply goods or materials from stock or on or within a given time or period are made subject to the availability of the goods or materials and on transport on the receipt of order.
2. While every effort will be made to meet collection or delivery arrangements, no liability will be accepted with regard to delay in supplying goods or in starting or carrying out work.
 1. We will accept no claim that goods, materials or work are unsuitable other than on the grounds of alleged defective workmanship or material. In any such case notification must be made in writing, within three days of delivery of such goods or material or the execution of such work and in any event the allowance shall not exceed the price charged for such goods, materials or work and will be limited to the direct cost of replacing or rectifying such goods, materials or work.
2. Once the Customer has accepted goods, materials or work supplied by us, whether by signing a delivery note or using such goods or materials or by approving such work or in any other way, he will be stopped from claiming that such goods, materials or work were unsuitable at the time of acceptance unless prior to or at the time of such acceptance he gave written notice specifying the unsuitable nature of such goods, materials or work.
 - The sizes and weights shown on price lists or quotations are approximate only, as variations in manufacture and materials cannot be avoided.
 - We will entertain no claim for breakage, damage or shortage in respect of goods sent carriage paid unless the following conditions are complied with:
If delivered by road by us: Breakages must be brought to the notice of the driver and noted on his receipt for delivery. Notification, in writing, must also be given to us immediately, and received by us within three days of the delivery of the goods.
If delivered by the customer's lorry: No breakage claim will be recognised, as our liability ceases immediately the goods are loaded into the customer's lorry at works or depot.
 - No claim will be allowed in respect of goods, products and materials supplied by us after such goods, products or materials have been laid, erected or otherwise used by the customer or another or others beyond our control in a manner contrary to our recommendations of good practice.
 - No liability will be accepted in respect of any error or omission in any layout drawing, plan, schedule or recommendation which we may submit as to the use of any goods, products or materials which we supply.
 - The customer shall indemnify us in respect of all costs which we incur through no fault of our own as a result of any change in the requirements after acceptance of order.
 - When monthly account terms are quoted, payment must be made by the end of the month following the month of delivery, no cash discount being allowed in the event of late payment.
